- o <u>Recreational 16U-19U</u> coed teams and <u>Classic 15U-19U</u> classic boy's teams will start the season playing Sunday late afternoon games. During the week of June 1, teams will also start playing weekday games. The full game duration will be played for all these games.

# **Dates for the scheduling process**

#### Classic 11U-19U Boys, 11U-15U Girls

#### All Deadlines are at noon of the date listed.

- · February 1-20, 2025- Team submitted to East Central League
  - o Submitted teams through PlayMetrics
  - o Enter Blackout out dates when submitting teams for scheduling.
- · Thursday, February 20, 2025- Clubs will receive a complete list of all teams.
- · Tuesday, February 25, 2025 Placement committee releases team placement
- · Thursday, February 27, 2025 Final day to appeal team placement.
- · Thursday, February 27, 2025– Appeals have been satisfied and scheduling begins.
- · Thursday, February 27- March 6, 2025 Schedule with date assignments sent to clubs. Clubs will work to put fields and times into the schedule. Keep traveling teams in mind when assigning times.
  - Thursday March 13, 2025, at noon. Any game that does not have a field and time assignment will lose their home game and it will be assigned to the traveling team. This club will also be put in bad standing. See rules about bad standing on the East Central website.
- · Thursday, March 6-27, 2025 Clubs can collaborate with each other to adjust dates changes.

- Tuesday April 1- 10, 2025 Classic schedule with Rec schedule introduced. (Clubs will need to enter time and field for Rec schedule) Clubs are encouraged to engage team coaches/managers/families for potential conflicts while working on this final stage. Coaches should not contact other coaches to request changes to the schedule. They must use their club scheduler to work out any conflicts.
- · Monday, April 7, 2025 Final requests for game changes
- · Thursday, April 10, 2025 Schedule is frozen and goes live. See rescheduling process.

- · Thursday April 10, 2025 Schedule is frozen and goes live. See rescheduling process.

# WYSA – State Rep Report

- o 2025 WYSA AGM will be March 8 at American Family Field
- o Birth yr vs School yr tentatively trying to get decided by November (July 31 cutoff)
  - 60% school to 40% birth nationally WI was 70% school vs 30% birth
- o 11/15 Deadline for WYSA sanctioned tournaments applications.
- o NEW ref courses are 3 hours of on-field instruction only
  - active space, which could be either an indoor gym/field house or indoor soccer court, restrooms
  - venue availability from 8:00 AM until 12:30 PM, or from 12:00 PM until 4:30 PM, on either a Saturday or a Sunday.
  - Class times are 9:00 AM-12:00 PM or 1:00 PM-4:00 PM, but additional time is needed for setup, take down, lay of the land, etc.

o Grant for New Ref course reimbursement ends 12/31

#### **TOPSoccer**

- o FIRE TOPS: Fire had 12 players register for our first Wausau/Point session. A lot of buddy help from the UWSP students. Looking at renting a larger facility because the gym is a little tight at times. Planning a winter session, not sure about dates yet. Starting our November sessions in Suamico on Tuesday evenings. #### Referee

- o The East Central and Bay areas have 542 registered referees.

- o 8U teams. Clubs need to make sure that teams are not using players as goalkeepers. The academy is a place to work with teams to develop players.

# **Old Business**

Motion was made by Brian Casey (Oshkosh) and seconded by Mike Jones (East Central Games Commissioner) to approve Clubs in Good Standing policy.

#### Discussion:

- The policy has been presented to the membership before, but it seems East Central did not pass a motion on the policy.
- An addition to the policy was added to help with fee collection. See the highlighted section below. Motion approved.

Definition of 'Clubs in Good Standing - For any organization to thrive it needs good partners, within the organization and outside. Partners with common goals, mutual respect and professionalism. For soccer to thrive and grow in our area the district needs good partners. A club's standing in the district is one of tools available to us to help ensure that the clubs that wish to be a part of USYS/WYSA soccer in Northeast Wisconsin are upholding/maintaining the values we have.

A. WYSA defines 'good standing' this way: A team or organization shall be considered in good standing if all of its players have been properly registered with their National State Association or approved organization and so long as the team or organization is not subject to any disciplinary sanctions prohibiting travel or hosting imposed by the National State Association, US Youth Soccer or approved organization.

- B. East Central further defines a club in 'good standing' as:
  - I. Attending East Central meetings
  - II. Having no past-due invoices
  - III. Completing district-requested actions on a timely basis. This includes but is not limited to:
    - a. Submitting applications for teams for league play
    - b. Field information uploaded for league play
    - c. Meeting district scheduling deadlines for league play
    - d. Player info uploaded
    - e. Game results reported
    - f. Payment of dues, fines and referee pay
    - g. Responding to district inquiries
  - IV. Teams appearing at scheduled games
  - V. In compliance with East Central's Policies and Procedures, having not intentionally nor egregiously violated East Central, WYSA, nor US Youth Soccer policies and procedures.
  - VI. There will be no service for a new season until the prior season is cleared and the upcoming season is paid in-full. Services withheld can include:

- a. registration of teams and players
- b. scheduling of teams for league play
- c. clubs may be required to pay for team scheduling services (no longer being invoiced by the district registrar)
- d. issuance of player pass cards
- e. insurance coverage
- f. ability to vote at district meetings

Any club in bad standing must prepay all district fees for league entry.

The duration of a sanction will be determined by the district, and a club's return to good standing will only come after a written request by the club to the district is considered, and the club's president meets with the (executive?) EC board, with the club outlining the steps they are taking to ensure they have addressed the issue(s).

If a club returns to bad standing after reinstatement, sanctions can be more severe and of greater duration.
